AmeriCorps Massachusetts Promise Fellows deliver the resources young people need to be successful in life by creating, managing, and leading meaningful out-of-school time programs for youth in grades 6-12. Fellow projects focus on mentoring, social and emotional learning, college and career readiness, academic enrichment, and community service-learning.

The Massachusetts Promise Fellowship achieves this by placing AmeriCorps Fellows with schools, non-profit organizations and state/local government agencies that focus on fulfilling the needs of our youth by providing: *a caring adult, a safe place, a healthy start, a marketable skill, and an opportunity to give back.*

The Boston Chinatown Neighborhood Center (BCNC) is a multi-service non-profit agency serving Asian Americans and the greater Boston community. The mission of BCNC is to ensure that the children, youth, and families we serve have the resources and supports they need to achieve greater economic success and social well-being.

SERVICE DESCRIPTION

Reporting to the Director of Youth Education, the Fellow serves as the College Access Coordinator and oversees the College Access Program (CAP) at BCNC Quincy. The Coordinator will work with primarily high school sophomores and juniors. The Coordinator is responsible for program development and design, evaluation, outreach and recruitment, and student advising. The Coordinator is BCNC's primary liaison with parents and support staff and faculty from area schools, regarding college access. In addition to these primary responsibilities, the Coordinator will work within BCNC Youth Center to provide office and program support where needed.

LOCATION: QUINCY, MA (WITH OCCASIONAL TRAVEL TO BOSTON)

ESSENTIAL RESPONSIBILITIES

- Develop a college access curriculum that covers topics that are culturally responsive and relevant to youth participants
- Organize and implement weekly college access workshops for 15-20 youth participants.
- Organize and implement 4-5 college visits for youth participants.
- Oversee the development and completion of a final project by youth participants.
- Oversee the development of a senior year portfolio for current high school juniors.
- Provide one-on-one and/or small group mentoring to youth on the college application process.
- Serve as a liaison between youth and other community resources.
- Maintain data tracking by preparing and keeping attendance, filing incident and accident forms as need, and maintaining relevant evaluation and program forms.
- Perform administrative duties such as filing, inventory, accounting, phone communications, etc.
- Travel at least once/month for Fellowship meetings, retreats, and training throughout the Commonwealth.
- Make a full-time, 12-month commitment.

QUALIFICATIONS

- Bachelor's degree in education, social work, counseling, or related fields.

- Knowledge of college application process, financial aid, and college admissions testing.

- Experience in curriculum development.

- Experience working in a multicultural, multilingual setting.
- Ability to prioritize tasks and maintain progress on short and long-term goals.
- Strong critical thinking and problem solving skills.

- (Preferred, but not required) Bilingual English/Cantonese or English/Mandarin speaking skills.
- (Preferred, but not required) Experience or knowledge of Asian American and/or Asian American youth issues.
- Must be a US Citizen, US National or Permanent Resident Alien.
- Must be willing to undergo a National Service Criminal History Check, including screenings through the National Sex Offender Public Website, a name-based search of the statewide criminal history registry both in Massachusetts and your state of residence upon application to our program (if not Massachusetts), and a fingerprint based FBI check. * Eligibility to participate in MPF is contingent on the results of this screening
