AmeriCorps Massachusetts Promise Fellows deliver the resources young people need to be successful in life by creating, managing, and leading meaningful out-of-school time programs for youth in grades 6-12. Fellow projects focus on and college and career exploration and academic enrichment.

**The Massachusetts Promise Fellowship** achieves this by placing AmeriCorps Fellows with schools, non-profit organizations and state/local government agencies that focus on fulfilling the needs of our youth by providing: *a caring adult, a safe place, a healthy start, a marketable skill, and an opportunity to give back.*

### Service Description:

The mission of Girls Inc. of Lynn is to inspire all girls to be strong, smart, and bold by meeting the needs of girls in the community, developing girls' capacity to overcome the effects of discrimination and be self-sufficient, responsible members of the community, and by serving as a vigorous advocate for all girls ages 5-18. The Massachusetts Promise Fellow will provide college access readiness programming for high school junior and senior girls which includes weekly programming featuring a 1:1 mentoring for the senior girls and team mentoring for junior girls. The College Access Fellow will teach girls about the college application process, scholarships and financial aid, increase girls' knowledge of colleges and scholarships that are a good fit for them personally, and engage the parents of girls in the program.

### Essential Responsibilities:

- Oversee the College Access Program by reviewing and updating schedules, curricula, policies and procedures to improve effectiveness
- Recruit, mentor, and guide the girls and their mentors through the college application process
- Assist with orientation and training for the volunteer mentors and parent/guardians
- Establish and maintained regular communication with program participants and their parent/guardians
- Plan, prepare for, and facilitate weekly college access mentoring sessions
- Track and record program data, including member information, training/program hours, attendance records, number of matches, student college acceptances, and scholarships awarded to mentees
- Work with staff to coordinate and implement other program components
- Maintain a Google Drive account for the program to share program resources
- Plan and implement activities to engage parent/guardians
- Complete program evaluation requirements including but not limited to preparing monthly reports, a youth attendance tracker, and time sheets
- Travel at least once/month for Fellowship meetings, retreats, and training throughout the Commonwealth

### Qualifications:

- Bachelor's degree or demonstrated equivalent of related experience preferred in education or related field
- Ability to work independently and take initiative
- Excellent organizational and communication skills
- Interest in and commitment to national and community service
- Familiar with the college and scholarship application processes
